The Sentence

Questions and Answer:-

1. What is a Sentence?

Ans. A sentence is a group of word which makes complete sense.

2. How many sentences are there? What are they?

Ans. There are 4 kinds of sentences.

They are:-

1. Assertive sentences
2. Interrogative sentences
3. Imperative sentences
4. Exclamatory sentences

3. What is an assertive sentences?

Ans. A sentence that makes a statement or assertion is called assertive sentences.

4. What is an interrogator sentences?

Ans. A sentence that ask a direct question is called an interrogative sentences.

5. What is an imperative sentence?

Ans. A sentence that expresses an order, request, advise and suggestion is called an imperative sentence.

6. What is an exclamatory sentences?

Ans. A sentence that expresses sudden and strong feelings is called an exclamatory sentences.

Subject and Predicate

Question & Answer:-

1. What is a subject?

Ans. The part which names the person or the thing we are speaking about is called subject.

2. What is predicate?

Ans. The part which tells something about the subject is called the predicate.

Phrases

Question & Answer:-

1. What is a phrase?

Ans. A group of word which makes sense, but not complete sense is called a phrase.

2. How many kinds of phrases are there? What are they?

Ans. There are three kinds of phrases

They are:-

1. Noun phrase
2. Adjective phrase
3. Adverb phrase

3. What is a noun phrase?

Ans. A noun phrase is a group of word which performs 4th the function of a noun in a sentence.

4. What is an adjective phrase?

Ans. An adjective phrase is a group of word which performs the function of an adjective in a sentence.

5. What is an adverb phrase?

Ans. An adverb phrase is a group of word which does the work of an adverb in a sentence.

Clauses

Question & Answer:-

1. What is a clause?

Ans. A clause is a group of word, having a subject and a finite form of a verb.

2. How many kinds of clause are there? What are they?

Ans. There are three kinds of clause

1. Adjective clause

2. Noun clause

3. Adverb clause

3. What is an adjective clause?

Ans. A clause that does the work of an adjective in a sentence is called an adjective clause.

4. What is a noun clause?

Ans. A clause that does the work of an noun in a sentence is called an noun clause.

5. What is an adverb clause?

Ans. A clause that does the work of an adverb in a sentence is called an adverb clause.

The Noun : Number

Question & Answer:-

1. What is singular number?

Ans. A noun that denotes one person or thing is said to be in the singular number.

2. What is a plural number?

Ans. A noun that denotes more than one person or thing is said to be in the plural number.
